Important requirements

The MFG requires that you contact your local, licensed plumber and licensed electrician to install your new spa. Installation MUST be in compliance with all local and state building codes. Your pedicure spa can not operate efficiently or safely unless it is provided with adequate electrical power, sufficient water pressure, proper water temperature, and required drainage capabilities. Contact your local building inspector for information and local code compliance procedure that need to be followed when having your new pedicure spa installed. Subsequent inspections and approvals that may be required are the responsibility of the purchaser.

Shipment Inspection (DO NOT DISCARD THE SHIPPING CARTON)

Examine the components immediately upon arrival to make sure no damages to the pedicure spa base and chair during the shipment. It is very important that you notify the driver directly and notation should be on the face of the freight bill or bill of lading of any damage. Failure to note damage on the bill of lading may prevent any claims you may have against the carrier.

If concealed or damage is found, you MUST notify the carrier at once and request an inspection. **DO NOT DISCARD THE SHIPPING CARTON** If receiver sign the carrier clean receipt of goods that have been damaged in transit .Do so at your own risk and expense.

Precautionary for using spa

- Do not stand in the basin of the spa.
- Excessive water temperature is dangerous and should be checked before use. Maximum water Temperature should not exceed 102~104F Degree.without health condition (See page 21 User's Recommendation).
- Always enter and exit the spa slowly and carefully. And Do not step on the bowl
- Never bring or operate any electrical device near pedicure spa.
- The unit has a weight capacity of 230 pounds.

Health Warning

Individuals whose feet or legs are inflamed or have open wounds should not be allowed to use the pedicure spa at any time. The technician should advise clients to consult their physician before using the spa if there is any sign of fungal infection, swelling, fracture, or persistent pain. In some cases diabetics may experience improved circulation in their feet, but should first consult their physician prior to receiving a pedicure.

If the client experiences any pain or discomfort, discontinue the use of the pedicure spa immediately.

IMPORTANT USER INSTRUCTION & SAFETY NOTICE. KEEP SAFE!

ELECTRICAL NOTICE

In order to ensure proper use, a separate **120v 60HZ 15amp(per dedicated outlet)** GFCI protected grounded circuit must be used to supply power to each pedicure spa. Failure to do so renders the Limited Warranty void.

**PEDICURE SPAS outside the US must be in accordance with the respective country's rules and regulations. For example, if installed in Canada, the pedicure spa must be in accordance with the Canadian Electrical Code Part1.

GROUNDING AND GFCI NOTICE

STOP! PLEASE READ PRIOR TO INSTALLATION AND USE!

When using electrical products, basic precautions should be followed:

- 1. Risk of electrical shock. Connect the pedicure spa only to a circuit protected by a ground-fault circuit-interrupter.GFCI)
- 2. Every EMPRESS Pedicure Spa must be installed by your local, licensed plumber and licensed electrician to install your new spa. Installation MUST be in compliance with all local and state building codes.
- 3. Your pedicure spa cannot operate efficiently or safely unless it is provided with adequate electrical power, sufficient water pressure, proper water temperature, and required drainage capabilities.
- 4. Contact your local building inspector for information and local code compliance procedure that need to be followed when having your new pedicure spa installed.
- 5. Subsequent inspections and approvals that may be required are the responsibility of the purchaser.

Shipment Inspection

It is very important that you notify the driver directly and notation should be on the face of the freight bill or bill of lading of any damage. TO REDUCE THE RISK OF BURNS, ELECTRIC SHOCK, FIRE OR INJURY:

- 1. Only authorized operators are permitted to use the pedicure spa.

Important installing Considerations

Please check adequate Electrical Rating & Hot water source Temperature setting based on Hot water source recommendation before installations.

Electrical Service

110V, 60Hz, 15Amp GFCI protected grounded circuit MUST be used to supply power each individual pedicure spa. And the main circuit breaker MUST be at 25Amp. For maximum of two units per each electrical outlet.

Water Supply

All plumbing connections must conform to local codes.

Water supply to the spa should be provided with adequate water pressure and water temperature.

Water pressure

To fill the basin correctly up to level, Normal water pressure of 30 to 80 PSI is required.

Water temperature (Source)

The hot water supply temperature must not exceed 120F / 48C.Or adjust your hot water source accordingly. For hot and cold water supply fittings and drain fittings location, see below diagram. Carefully connect the water supply line to the appropriate fittings located on the rear of the pedicure spa. Shut-off valve are recommended (not provided).

The pedicure spa Drain must meet local plumbing codes. Check valve for Drain (not Provided) Must be installed by a licensed plumber. Also Pedicure spa must be securely fasten to the floor.

Installation Summary

The installation must comply with local, state, and federal building, plumbing and electrical codes, where applicable. A licensed plumber should complete the plumbing of the pedicure spa.

Maintenance and Cleaning of PU Synthetic Leather

PU synthetic leather is made from polyurethane resin after coating, drying and curing. Compared with the genuine leather, PU synthetic leather is more resistant to acid, alkali, heat and sunshine. However, because of its own physical and chemical properties, it should not be put at the place where there is dust, high temperature, high humidity, low temperature or strong sunshine and the environment containing acid and alkali agent and solution. Otherwise, it will be easily cracked, quickly aging and hydrolyzed.

Cleaning methods of PU synthetic leather and precautions:

- 1. Organic agent, grease solution and compounds, especially the strong solvent, e.g. alcohol, turpentine, thinner can not be used for cleaning the PU surface and otherwise the PU surface will be easily corrosive.
- 2. Fresh water or washing powder can not be used for cleaning the PU surface or there will be cracks.
- 3. Environment-friendly detergent which is containing no abradant and with a PH value of 5-7 should be used for cleaning the PU surface.
- 4. For the quite dirty PU surface, use a soft cloth with egg white to wipe the dirt, brush should not be used for cleaning the surface.
- 5. The more popular detergents in the market are: Meipingwang leather detergent and protective agent; Amway leather detergent, etc.
- 6. For the best result for maintaining your PU synthetic leather please inquire Empress for **Spa Leather Cleaner**.
- 7. Fabric inside liner and fabric padding MUST be check quarterly for the best result. In case of warn out please contact service department for replacement. (Worn and tear is not covered under warranty)

Maintenance methods of PU synthetic leather and precautions:

- 1. Good room ventilation should be ensured because too dry or too wet environment will fasten the aging of leather.
- 2. Leather sofa should avoid direct exposure to sunshine or air-conditioner wind; otherwise the leather surface will become hard. Direct exposure to sunshine will make the leather with color faded.
- 3. There is more sweat on body during the summer the hole of the leather will absorb the sweat. The organic matter in the sweat and the leather will have a chemical reaction during high temperature and wet environment, and there will be peculiar smell. For this, wettish soft cloth should be used for wiping frequently.
- 4. While wiping the sofa, the alkali cleaner should not be used because there is acid treatment during leather making and the alkali will decrease the pliability of the leather and there will be crack if the alkali cleaner is used for wiping the sofa.

USER MAINTENANCE INSTRUCTIONS CLEANING AND DISINFECTING YOUR PEDICURE SPA

Note: Please be advised that it is responsibility of purchaser/user to adhere strictly to the following procedure. Any non-compliance will be considered negligence of the purchaser/user.

The Bureau of barbering and cosmetology requires that salons using whirlpool pedicure spas use the following disinfecting Procedures to ensure proper cleaning and maintenance of the equipment, and to prevent bacterial infection. For your clients safety, always use the regulations as a minimum standard for cleaning and disinfecting.

Chair maintenance: Please see chair manual for Do and Don't

A SPECIAL NOTE PERTAINING TO BLEACH

While bleach seems to be used extensively for cleaning and disinfecting of pedicure chair basins, it is NOT recommended nor is it effective. Moreover, excessive use of bleach may greatly reduce the longevity of your pedicure chair internal components (i.e. pumps, jet waste assembly, etc.). Excessive and repeated use of bleach may also void your warranty. As always, you are required to check with your state board for mandatory cleaning and disinfecting requirements and procedures.

At the end of the day:

- 1. Remove the intake suction screen, All debris trapped behind the screen of each pedicure spa must be removed. And the screen and the inlet shall be washed with soap or detergent and water
- 2. Before replacing the screen, Totally immersed the screen into an EPA- registered disinfectant with bactericidal, Fungicidal, and virucidal activity.
- 3. Finally, flush the whirlpool system with low-sudsing detergent and warm OR an EPA registered cleanser for 10 minutes. Rinse with clean fresh water and drain.

Note:

Cleaning or sanitizing is NOT disinfecting. According to the CDC and EPA, disinfecting occurs only when there is a reduction of pathogenic microbes at 99.999%. Sanitizing is a only reduction of 99.9%. Cleaning of whirlpool pedicure spa requires surfactant and chelating detergents that are low foaming and have ability to remove body oils, organic oil additives, mineral oil, skin cell, nail clippings, etc.. That can accumulate both in the basin and the jets which may become fertile area for micro organism to grow.

Note:


The use of oil based products can build up in the whirlpool system causing clogging in the jet and build up onto the surface of the basin. Adherence to the above cleaning will minimize build up thus the manufacturer recommend not to use mineral oil based product.

Installation Instruction




Fig1: Connection Diagram

- Make a hole (size 1-3/8") for the On/Off switch as shown (see fig 1) pre-drilled
- Placed a 1/8" clear hose into the rear of the switch and on/off switch into the hole.
- 3. The discharge pump kit is made to fit onto the pedicure unit. (see fig 2)
- Connect E-Z connector onto the drain elbow.
- Plug discharge pump outlet into the two minute timer outlet
- Plug two minute timer into the wall outlet.
- It is very important that tip of the clear tub remain above the water level

** Please cut to fit Flex hose to size**



l) Overall System Integration

Attention: All J&A Pedicure Spa equipped with Backflow Protection prevent water contamination (see Manual) if Local or State required specific Backflow Protection Device, the owner must be installed according to the local and State requirement.

II) System Installation

Follow the steps below for iFill 5 installation

- a) Connect the Flow Sensor/Water Valve Package to the output of water mixer/faucet. Be sure the water flow direction is correct.
- b) Connect the Control Keypad and Flow Sensor/Water Valve Package to MasterBox

Automatic Fill Volume Setting:

The volume of each Auto iFill can be set by the knob located next to the power cord on Masterbox. Depending on the knob position, water valve shuts off when water volume reached the set value.

How To Change the Temperature Unit (Fahrenheit or Celsius):


Be sure all buttons on keypad are off, press and hold the END/DRAIN button for 5 seconds until F or C is displayed on the keypad.

III) How to operate the iFiII 5 (Be sure that the faucet is)open

ATTENTION: BEFORE PRESSING AUTO IFILL BUTTON, BE SURE PREVIOUS SESSION IS COMPLETE AND DRAIN OUT WATER IN THE BASIN. TO UNLOCK THE AUTO BUTTON, PRESS END BUTTON.

- Press the Auto/iFill button to turn On or Off the Automatic fill.
- Press the JET button to turn On or Off the JET and color light manually (1 hour timer)
- Press the Wash button to turn On or Off the water manually (5 minute safety timer)
- Press End/Drain button to end the session and unlock the Auto fill button. This button will also turn on the drain pump.



- 1. Turn off the unit and wait until the motor is fully stops.
- 2. Hold hydro whirlpool jet cover firmly and pull to separate from the round magnetic field.
- 3. Turn hydro whirlpool jet cover to left to open and pull out impeller.
- 4. Use Anti Bacterial solution (EPA Registered) to clean all parts.
- 5. After sanitize all parts, place impeller and close hydro whirlpool jet cover to turn right to lock
- 6. Hold firmly the whirlpool cover jet and gently place it onto the round magnetic field. Do not release the hydro whirlpool jet cover until jet cover is on the round magnetic housing.


WARNING: DO NOT RUN DRY, BASIN MUST FILLED WITH WATER TO LEVEL INDICATOR.

CAUTION: MAGNETIC JET COVER ASSEMBLY MUST ALIGN WITH DISCHARGE PORT POSITIONED AT 3/9 O'CLOCK.

When Ready to use, **MAKE** sure jet cover is positioned at 3/9 O'clock for proper whirlpool action in the basin. If jet cover is not align at 3/9 O'clock, water will splash outside of the basin.

Proper way to use Magnetic Jet System:

- 1. Fill the water to water level indicator.
- 2. Hold Magnetic Jet firmly to bring closer to the round magnetic filed and do not release the Magnetic Jet prematurely or this will cause impacts on the jet cover and the round magnetic field(housing) shortening the life expectancy of the jet cover. When the jet cover nears the round magnetic field, place jet cover onto the four dimple area (see diagram). The jet cover must align with discharge ports positioned at 3/9 O'clock.
- 3. When finished with client, DO NOT remove Magnetic Jet until motor is fully stopped.
- 4. When motor is fully stopped, remove Magnetic Jet cover from the motor and remove jet cover and impeller for sanitation.




