





Installation must comply with all state and local building codes.

Pedicure spas cannot operate efficiently or safely unless provided with adequate electrical power, adequate water pressure, proper water temperature, and required drainage.

Warranty coverage includes repairs and adjustments needed to correct any defects in materials or workmanship, or any part supplied by J&A USA Inc. from the date of purchase. Massage/Vibration pedicure chairs are covered under warranty for 24 months, excluding noise, vibration, cosmetic conditions, and other deterioration caused by normal use. Fiberglass pedicure tubs are covered under warranty for 24 months, excluding damage resulting from striking or leaping onto the base, damage due to direct sunlight or exposure to light bulbs, or normal wear to metallic plated hardware, stickers, and paint. Pedicure glass bowls are covered under warranty for 24 months, excluding damage from impact upon striking or leaping onto the bowl, or surface degradation caused by contaminants in water, such as calcium and mineral deposits.

This warranty covers repairs and adjustments needed to correct defects in materials or workmanship of any part supplied by J&A USA Inc., except in the case of fire, accident, or theft. Damage from misuse, such as striking or leaping onto the unit, damage from improper repairs, alterations, tampering, or failure to perform proper maintenance will not be covered. If J&A USA Inc. receives notice of defective products during the applicable warranty period, J&A USA Inc. shall either repair or replace the defective parts at J&A USA Inc. discretion. The replacement product may either be new or be the equivalent in performance to new.
